## GUIDING PRINCIPLES FOR PROSECUTION OF CASES IN JACKSON COUNTY

*The duty of a public prosecutor is to seek justice, not merely to convict. "The state's attorney in his official capacity is the representative of all the people, including the defendant, and it was as much his duty to safeguard the constitutional rights of the defendant as those of any other citizen." People v. Cochran, 313 Ill. 508, 526 (1924). The interest of the state's attorney's office in a criminal prosecution "is not that it shall win a case, but that justice shall be done. As such, he is in a peculiar and very definite sense the servant of the law, the twofold aim of which is that guilt shall not escape or innocence suffer. He may prosecute with earnestness and vigor-indeed, he should do so. But, while he may strike hard blows, he is not at liberty to strike foul ones. It is as much his duty to refrain from improper methods calculated to produce a wrongful conviction as it is to use every legitimate means to bring about a just one. Berger v. United States, 295 U.S. 78, 88, 79 L. Ed. 1314, 1321, 55 S. Ct. 629, 633 (1935).*

With these principles as our policy, the following guidelines apply:

1. Prosecutors in our office may only bring charges in instances where it would be reasonable, based upon admissible evidence, including both direct and circumstantial evidence, for a jury to conclude that the evidence supports a conviction, beyond a reasonable doubt. Conjecture and speculation are inadmissible and may not be a basis for bringing a charge.
2. In determining what charge to bring against an adult in a non-traffic case, when an offense involves: a crime of violence; a crime committed by a prior felon; a drug offense involving violence or a firearm; a residential burglary; a serious property offense; an offense involving a child or a disabled or elderly person; or a public corruption offense, prosecutors should file the highest, readily provable offense, and any other charge which may reasonably support an alternative theory of guilt.
  - a. If a minimum mandatory sentence is called for by statute, that charge, if provable, should be filed and prosecuted and may not be dismissed or negotiated below the minimum mandatory sentence without approval of the State's Attorney.
  - b. If the reports and available evidence do not support bringing a charge pursuant to the principles established herein, no charge may be filed. If an arrest has been made under such circumstances, every effort should be made to immediately determine the existence of any evidence not mentioned in a report to support a charge, or, if none exists, to authorize the release of the person arrested.
3. In instances where the offense is not serious, prosecutors should avoid filing enhanced charges, or making allegations which would cause the charge to become a felony.
4. Except for statements that are necessary to inform the public of the nature and extent of the prosecutor's action and that serve a legitimate law enforcement purpose, prosecutors should refrain

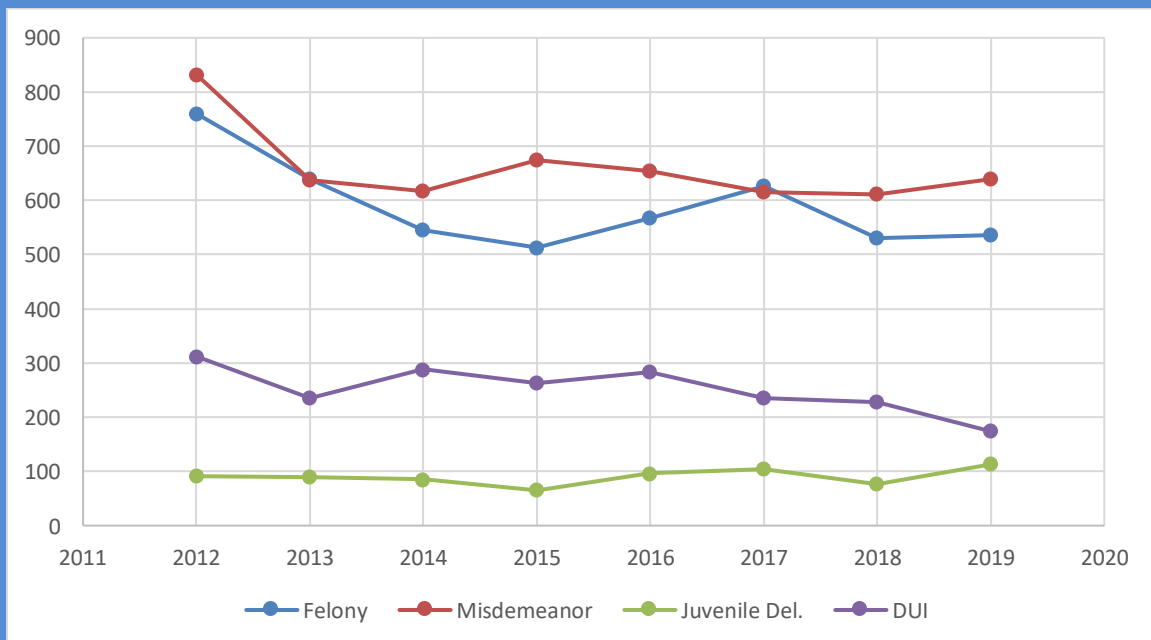
from making extrajudicial comments that pose a serious and imminent threat of heightening public condemnation of the accused and exercise reasonable care to prevent investigators, law enforcement personnel, employees or other persons assisting or associated with the prosecutor in a criminal case from making an extrajudicial statement that the prosecutor would be prohibited from making under Illinois Supreme Court Rules 3.6 or 3.8.

- a. Any statement by our office indicating that a person has been charged with a crime must include a statement that the charge is merely an accusation and that the defendant is presumed innocent unless proven guilty.

### Case Filing Trends

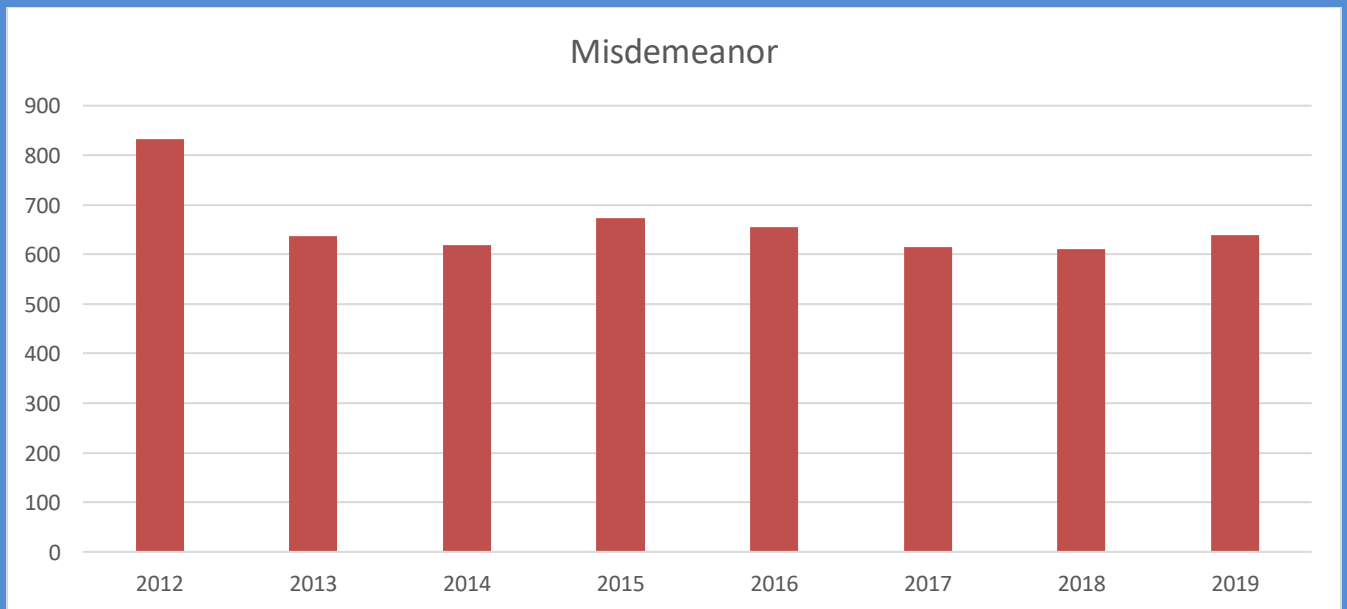
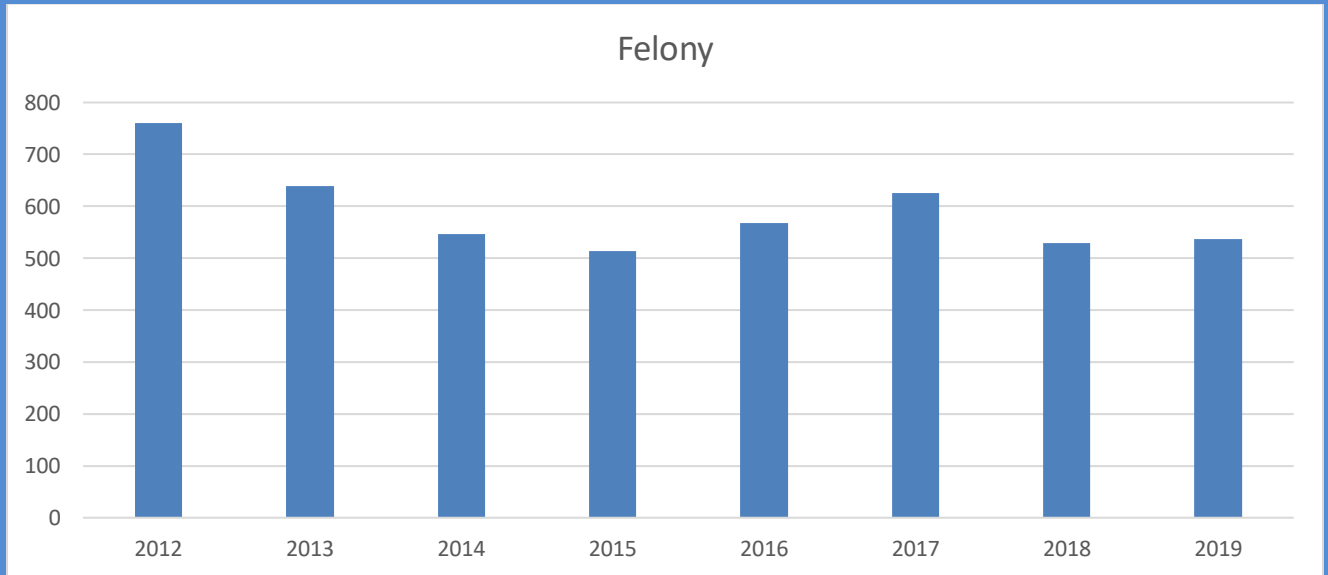
Felony and misdemeanor case filings have declined dramatically overall since 2012. Juvenile delinquency filings and DUI cases have also significantly declined over the same period. Case filings for each year are listed below:

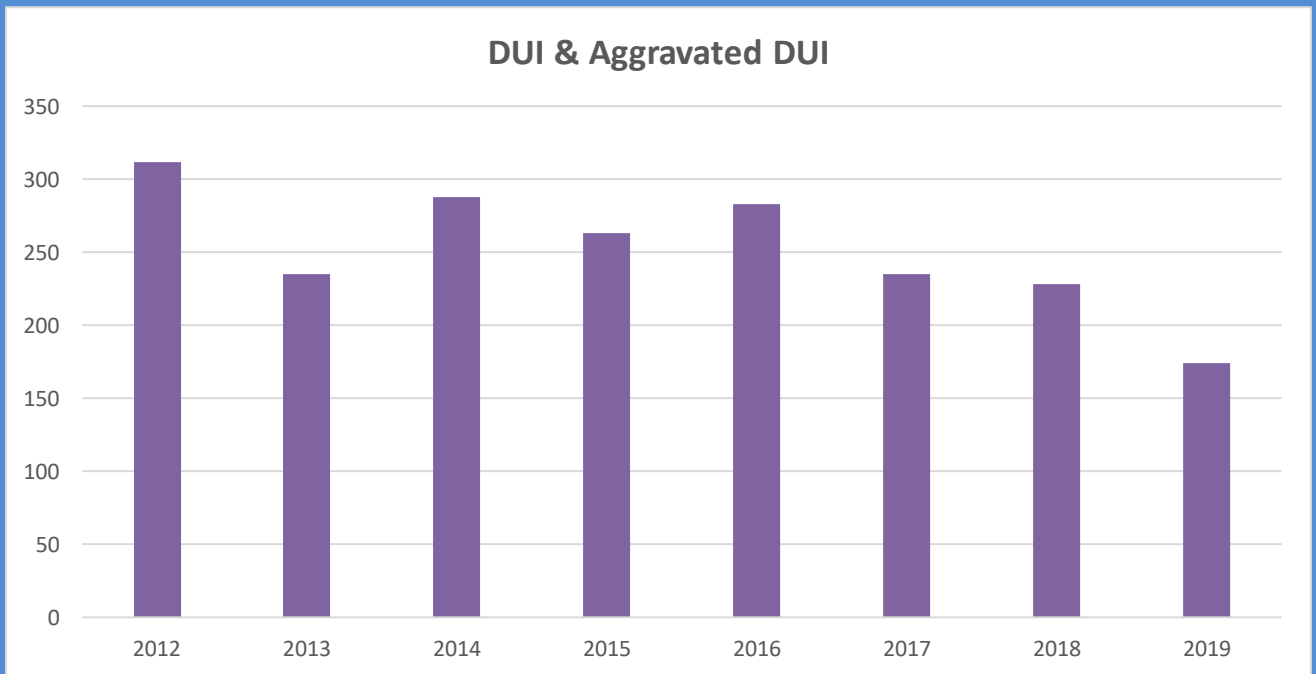
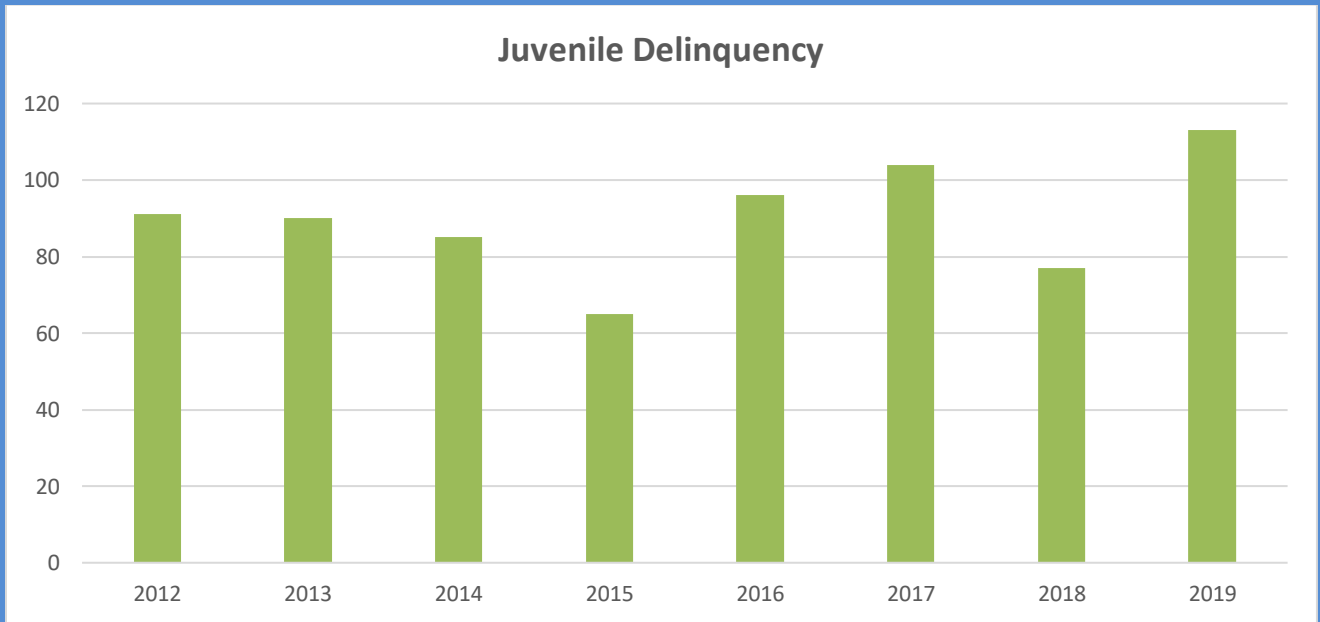


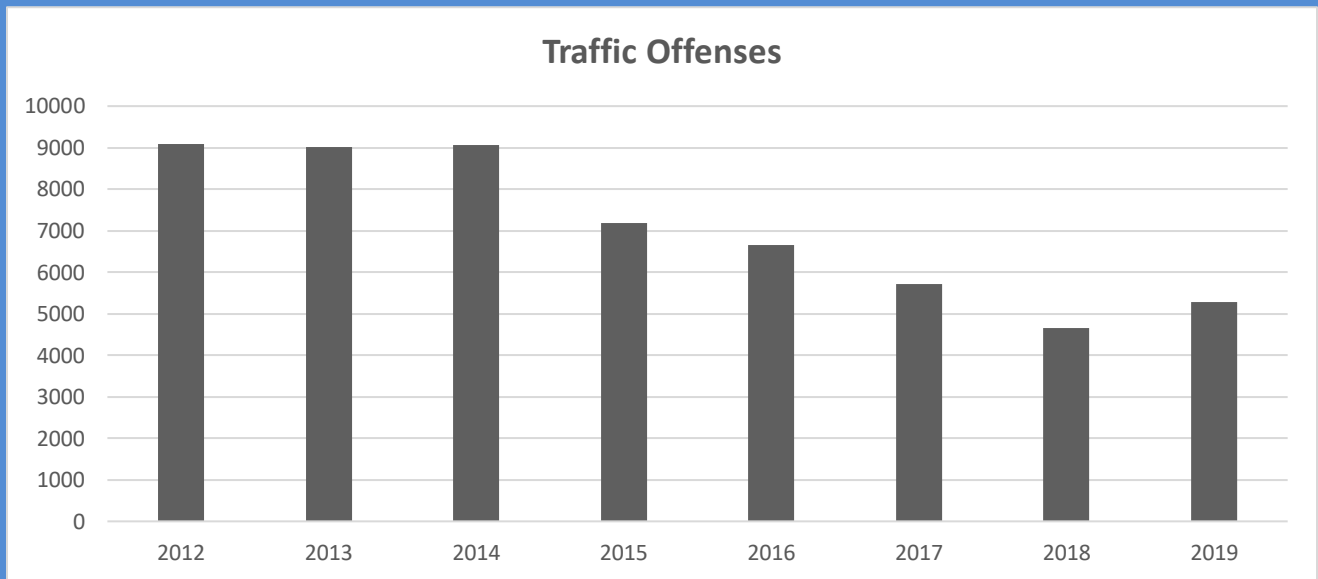
The focus of our office remains on processing cases involving the most significant violations committed by recidivists and securing the removal of those offenders. So, while the overall numbers have declined, our office resources remain stretched because it takes more time.

### Breakdown of Case filings



These cases reflect criminal charges which were filed against juveniles.





These traffic cases include offenses such as driving on a suspended or revoked license, reckless driving, speeding, no insurance, too fast for conditions and traffic sign violations. Despite the overall decline, the volume alone is staggering for the court. Each of these cases represents potentially one to three or more appearances in court before the case is completed.

## PRISON SENTENCING

The state legislature has determined that the most serious offenses committed by offenders against the public justify mandatory minimum sentences. These offenses include among others: Murder, Armed Robbery, Sexual Assaults, Home Invasions, Kidnapping, and Home Burglaries. When we believe that such an offense can be proved, our office will file and not reduce that charge or negotiate it in a way that would cause the sentence to be below the minimum sentence called for by the legislature.

In addition to mandatory minimum sentences, our office has also focused on offenders who have recently been released from prison. According to research released by the Bureau of Justice Statistics, about two-thirds (67.8%) of released prisoners were arrested for a new crime within 3 years, and three-quarters (76.6%) were arrested within 5 years.<sup>1</sup> So, we have focused on those charges committed by offenders who have already been convicted.

Our office does not impose sentences but does have the ability to influence sentences through recommendations to the court and by not dismissing or reducing serious charges which carry mandatory sentences.

- **Between December 1, 2012, and December 31, 2019, 90 offenders have received prison sentences of ten years or more (Natural Life, , 120, 88, 85 (x2), 80, 75 (x2), 74, 40 (x2), 35, 34, 32, 31, 30 (x4), 28, 27 ½, 27, 26 (x2), 25 (x5), 23 (x3), 22, 21, 20 (x6), 19, 18 (x4), 17, 15 (x8), 14 (x2), 13, 12 (x9) and 10 (x25).**
- **122 offenders have received sentences of 5-9 years.**
- **250 offenders have received sentences of less than five years.**

### Nonfatal Domestic Violence

Domestic violence cases, by nature, continue to present challenges to the resources of police departments, the courts, our office and the county jail. By statute, police officers in Illinois are required to provide assistance to a victim of domestic violence whenever there is “reason to believe that a person has been abused by a family or household member and to use all reasonable means to prevent further abuse. . . .” 725 ILCS 5/112A-30. In most instances, law enforcement has interpreted this statute to mean that an arrest is mandatory, despite other alternatives listed in the statute being available. As a result, although there may be reasonable cause to make an arrest, in many instances there is insufficient evidence to support charges or convictions and the person who has been arrested must be released. This practice has led to a large number of arrests which cannot be sustained because they inevitably end up pitting one party’s word against the other’s without sufficient corroboration to support either version beyond a reasonable doubt.

On some occasions, officers have become frustrated at the inability to determine who the perpetrator was and have arrested both parties involved in the domestic violence incident. This practice has been condemned by domestic violence professionals and state’s attorneys throughout Illinois because of the inability to obtain testimony from witnesses who are both charged defendants in the same incident. From a safety perspective, a victim who has been arrested after calling for help in a domestic violence incident will be less likely to report future acts of violence against her if she believes that it will result in her arrest, so this practice should be avoided.

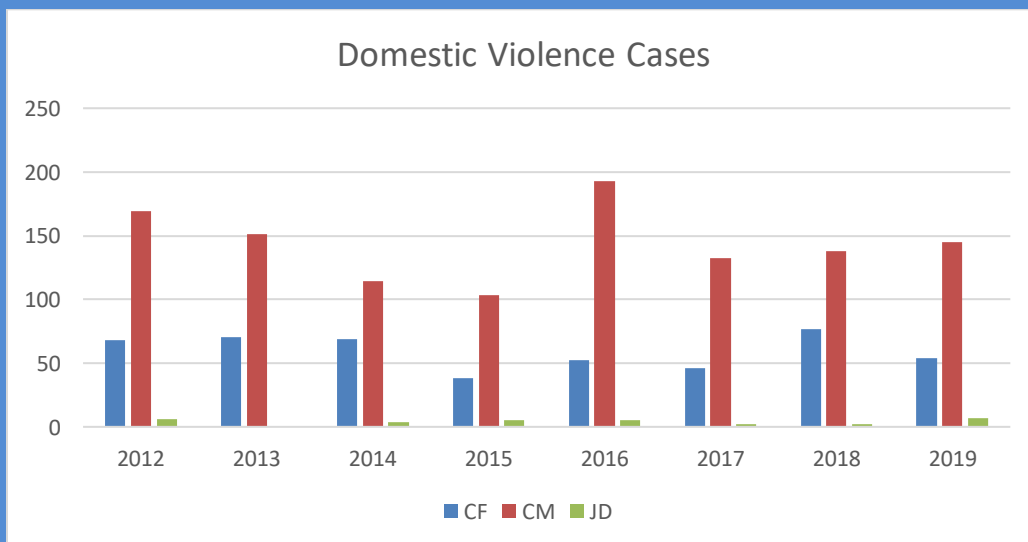
It is the policy of this office to support lawful arrests by law enforcement, but assistants have been instructed not to file a criminal case in circumstances where the evidence does not support a charge or conviction which can be proved beyond a reasonable doubt or in instances where the victim has requested that no charges be filed. Our victim witness advocate has been trained in advising and assisting victims with orders of protection as an alternative to prosecutions.

### Case Filing Trends

With the exception of 2016, the total number of Domestic Violence cases filed in Jackson County is down since 2012.

## Dismissals and Declinations of Domestic Violence Prosecutions

The overwhelming majority of the cases submitted to our office in this category involve minor or no injuries at all and are declined (before filing) or dismissed (after filing) at the victim's request or because the offense cannot be proven beyond a reasonable doubt. Many declinations involve reports submitted by officers who have not made an arrest because the officer cannot decide who the aggressor was. Of the 3,709 cases submitted to our office by police agencies for review since December 2012, 2,059 have been declined before filing, and 1026 cases have been dismissed after filing. Of those which have been filed in court, 612 have resulted in convictions and only 12 have resulted in acquittals. Dismissals of cases have declined generally since 2012.

### Community Programs

Our office, in collaboration with the Batterers Intervention Program, which is under the auspice of the Carbondale Police Department, has developed a diversion program to deal with qualifying domestic violence offenders. Our office has agreed to recommend offenders, where the injury is minimal and with the consent of the victim, to participate in the program with the understanding that no charges will be filed upon successful completion of the program. The



Batterers Intervention Program is modeled after the Duluth Model and is facilitated by various networking partners within the Violence against Women Grant agreement.

Since starting the above program, we started a group for women that batter. This group is open, and the participant numbers vary from week to week.

In addition to the Diversion Program and the Batterers Intervention Program, our advocate, in collaboration with the Carbondale Police Department's advocate and the Jackson County Sheriff's Department's advocate, facilitates another group for women who have been impacted by domestic violence. This group is open and meets weekly.

In 2019, we had 52 active participants in the various groups listed above. The participants come to the programs through various means. Some group participants are self-referrals, some are Diversion Program participants, and some participants are referred by probation, police, or the Department of Children and Family Services. All the groups are open groups, meaning participants can enter the program at any time, they do not have to wait for the 24-week course to start at the beginning. The participant numbers vary from week to week as participants join and graduate.
